# Sound Therapy Distributor Contract –*Sound Therapy Copy*

Distributor means the person contracting to sell Sound Therapy Products on behalf of Sound Therapy International Pty Ltd  
The Company means Sound Therapy International's head office.

To become a distributor for Sound Therapy the applicant must complete the distributor contract and return it to the Company with full payment for the Distributor Essentials Pack.

Upon acceptance of the distributor contract by Sound Therapy International, the Distributor is authorised to purchase Sound Therapy products at the discounted distributor price as specified by the Company from time to time.

Purchase orders to the Company must be accompanied by full payment at the distributor discount.

There are no restrictions placed on the Distributor as to territory.

The Distributor may conduct its distributorship activities as it sees fit but shall do so at its own cost.

The Distributor is not an agent or an employee of the Company nor a person acting on the Company's behalf.

The duration of this contract is for one year from the date of acceptance by the Company and provided the Distributor has not breached the contract it will be renewed by the Company for successive terms. An annual renewal fee of \$15 is payable in December of each year except where a new Distributor has joined since 1 July in that year.

The distributor agrees:

- (a) Not to make any claims or representations on behalf of the company apart from explaining the information as set out in the Sound Therapy International literature.
- (b) Not to breach the confidentiality of any clients without their express permission to disclose information about them in a public forum.
